THE COVID-19 PANDEMIC

TWO YEARS AND COUNTING


arch 13, 2020, started like any other school day for Newton County School System (NCSS) students. An early release day for a scheduled teacher workday, students left for the weekend not knowing it would be the last day of inperson instruction for the remainder of the school year. By Monday, schools were closed due to the pandemic, with an expectation that they would soon reopen. That of course, never materialized. The 2019-2020 school year flipped to strictly virtual





learning, with students never stepping foot back into their school buildings.

While COVID-19 hit the nation, our community, and our school system hard, NCSS students and staff were up to the challenge. Chromebooks and hot spots were offered to students free of charge and teachers began teaching remotely from home. The NCSS school nutrition staff switched gears and offered free breakfast and lunch meal pickup at select school locations. Soon thereafter, district bus drivers began delivering free meals throughout the community to ensure that all Newton County children received nutritious meals while families sheltered at home. Free meal pickup and delivery options were offered throughout the remainder of the school year and into the summer months.

After an extended summer break—students reported back for the 2020-2021 school year on September 8, 2020, in one of three ways—in-person, virtually, or by self-paced virtual learning. Mask wearing became the norm and students and staff were encouraged to practice social distancing and hand washing/sanitizing throughout the day. Schools experienced temporary closures throughout the year due to COVID-19 outbreaks but students and employees still persevered. Students competed and won in numerous virtual regional, state, and national competitions throughout the year; our seniors earned millions of dollars in college scholarships; and our staff worked tirelessly to ensure our schools continued to operate seamlessly. Were there hiccups along the way? Of course! It was—and still is—a global pandemic. But Newton County School System proved it was up to the challenge as evidenced by the numerous accomplishments highlighted in this annual report, covering both the 2019-2020 and the 2020-2021 school years. Newton County School System's motto is Spirit, Pride, and Excellence, and our students and staff have exemplified those words throughout the COVID-19 pandemic!



NCSS Graduation Rate

Newton County School System's (NCSS) four-year, cohort graduation rate continued to best the state rate in 2021. In addition, all three high schools—Alcovy, Eastside, and Newton—also topped the state.

The four-year adjusted cohort graduation rate defines the cohort based on when a student first becomes a freshman. The rate is calculated using the number of students who graduate within four years and includes adjustments for student transfers.

Newton County School System 2021 ACT Scores

Newton County School System (NCSS) students increased their scores across the board on the 2021 ACT with English and Reading both seeing gains of 1.6 points. The district's Math, Science, and Composite score all increased by 1.5 points in 2021. In addition, Newton County School System students bested their national counterparts by one-tenth of one point in Science. The number of test-takers did decrease in 2021 both locally and across the state and nation. This is attributed to the impacts of the COVID-19 pandemic, including the temporary waiver of SAT/ACT score requirements for University System of Georgia admissions.

According to the official ACT report, Alcovy High School students posted significant gains in 2021 with English increasing by 2.6 points and Math increasing by 2.1 points. The school's Science score rose 1.7 points and Reading increased by 1.2 points. As a result, the school's overall composite score rose two points in 2021. In addition, Alcovy students surpassed the national averages in English, Science, and the composite and matched U.S. test-takers in Math.

Eastside High School students also posted gains across the board on the ACT in 2021 and bested the nation in every category, too. The school's English score rose one point and Math increased by seven tenths of one point. Both the Reading and Science scores rose one-half of one-point. Overall, Eastside's composite score rose by seven-tenths of a point.

Like their counterparts at Alcovy and Eastside, Newton High School students also posted gains in every category of the ACT in 2021. Science rose 1.1 points and Reading increased 1.5 points. The school's English score increased by half of a point and Math rose six-tenths of one point. Overall, Newton's composite score rose .9 points last school year.





NCSS 2021 **SAT SCORES**

Newton County School System (NCSS) SAT test takers posted outstanding results in 2021, increasing their total composite score by 43 points to 1035. Overall, NCSS students increased their Evidenced-Based Reading and Writing Score by 16 points to 529; math scores rose 27 points to 506.

At the school level, Alcovy High School students increased their scores across the board in 2021, with their composite score soaring 44 points to 1018. Alcovy students increased their Evidenced-Based Writing by 24 points and their Math score by 19 points in 2021. Although Eastside High School saw a slight dip of two points on the Evidenced-Based Writing in 2021, their Math scores shot up 11 points, which raised the school's composite score to 1086 in 2021, surpassing both the national test takers and Georgia's public school test takers. Finally, Newton High School students posted increases in every category in 2021. Their Evidenced-Based writing score increased 12 points and Math shot up 29 points in 2021. As a result, the school's composite score saw a 40 point boost, going from 953 to 993.

The honors kept coming for Newton County School Superintendent Samantha Fuhrey in December 2019 when she was named both the Georgia 2020 Superintendent of the Year and later one of only four finalists for the 2020 National Superintendent of the Year! She was the only female national finalist!



"It is quite an honor to represent Georgia, the Newton County School System, and community as a national finalist for Superintendent of the Year," said Fuhrey. "I would not be in this position without our dedicated school system team, our hard-working students, and our supportive community. Together, we have made strides to ensure that we achieve our vision that all students are well-rounded and prepared for the future. I consider this an honor to be shared with our NCSS team, students, families, and our community partners. Newton County is truly a special community that supports its public school system. As a result, our students have benefitted from and have shown time and time again that they can compete with their peers at the regional, state, and national level."

Fuhrey added, "I would be remiss if I didn't publicly acknowledge the tremendous support I receive from our school board. Together they are a fantastic team that puts the children of our district first in every decision they make. Not all school superintendents are so fortunate to work with such an amazing group of men and women. They truly want what's best for our students and employees."

"We are absolutely excited that Mrs. Fuhrey's leadership, commitment to public education, and innovative practices have gained recognition nationally by becoming one of the top four finalists in the nation for Superintendent of the Year," said Shakila Henderson-Baker, then chair of the Newton County Board of Education. "Her leadership for learning and her implementation of programs in our district have been centered around national topics that

have impacted school systems everywhere. This has not only helped us to be proactive versus reactive, but it has also brought attention to our school district nationally on platforms like CNN and at national educational conferences. Her drive to be innovative and a forward thinker is also one of the reasons her peers from other districts respect her and seek out her guidance. I spoke with a superintendent in another district recently at a conference about this and his response was, 'when they ask, she's always willing to assist them.'"



Remembering Mr. Almond Turner

ith deep sadness, the Newton County School System announced the tragic death of school board member, Mr. Almond Turner, on November 23, 2019. A beloved member of the Newton County Board of Education, Mr. Turner served the residents of Newton County's fourth district. Mr. Turner had a servant's heart, which led him to a 45-year-career in law enforcement; he retired as assistant chief of police with the Covington Police Department in December 2016.



Mr. Turner was a 1968 graduate of the historic R. L. Cousins High School and attended Fort Valley State College where he majored in music. He also attended DeKalb Community College where he earned an Associate of Arts degree in Criminal Justice. He furthered his education at Troy University, receiving a Bachelor of Science Degree in Criminal Justice. He was a 1982 graduate of the FBI National Academy (Quantico, Va.), as well as a 2002 graduate of Columbus State University's Command College.

A proud graduate of the Newton County School System, Mr. Turner was first elected to serve on the Board of Education in 1996. He was re-elected in 2000, 2004, 2008, 2012, and 2016. During his tenure as a board member, he employed his law enforcement and security experience to improve safety measures throughout the school system, which included the installation of cameras in all school buses and all classrooms. He also fought for changes in school policies to make sure that any policies implemented would be fair and equitable to students, teachers, and administrators. Mr. Turner was committed to supporting teachers and ensuring they had the necessary tools needed to provide children a quality education.

Mr. Turner had a passion for music and was well known for his support of and performances in the Newton County Community Band. He was also a beloved member of the Springfield Baptist Church, where he served as a deacon and oversaw the Ministry Protection Team.

Born in Covington, Mr. Turner was the son of the late Lavancy Maxey Turner and Almond Turner. Mr. Turner was survived by his wife, the former Anita Franklin, three children—Dwahn, <u>Shaye</u>, and <u>Shundra—and ten grandchildren</u>.

"We are stunned, devastated, and heartbroken," said Samantha Fuhrey, superintendent of the Newton County School System. "Mr. Turner was a life-long supporter of our community and its school system. He always wanted and fought for what was best for our students and employees and we looked forward to him continuing to serve on our school board into the foreseeable future. But more importantly, on a personal note, Mr. Turner was my friend and mentor—someone who helped guide me as I began the journey as superintendent of this school system. I will never forget his advice, his kind words of encouragement, and most of all his friendship. There will never be another Almond Turner. He was truly one of a kind."

Then Newton County Board of Education chair, Shakila Henderson-Baker said, "Mr. Turner was a leader in our community and our school system. This is hard. Almond was and is a man who spent his life serving and protecting others, whether it was serving on the police force

or serving the community as an advocate for public education. I am shocked to hear of this tragedy. He will absolutely be missed."

Mrs. Henderson-Baker added, "Almond is a hero to all of us. He was the backbone of our school board. He encouraged us. He fought for the best interest of our children. And he was our friend. I am absolutely devastated at this loss. I grew up seven doors down from Almond Turner. He watched me grow up from a little girl. My dad died two days before my first election but Almond came to me and said, 'I got you.' And now my 'I got you' is gone. I am devastated. We all are."

The Newton County School System was not alone in grieving the tragic passing of Mr. Turner. The entire Newton County community was in a state of shock upon hearing the news. Numerous residents lined the route when Mr. Turner was brought home to Covington in preparation for his funeral. And hundreds more attended a candlelight vigil on the Square in Covington, where numerous dignitaries spoke and paid tribute to him.

On the day of his funeral, the Newton County Board of Education held a special called meeting to adopt a resolution in Mr. Turner's honor. Signed by all four remaining board members, the resolution notes that Mr. Turner "provided quality leadership to the Board of Education" and that he "actively promoted public education and supported excellent educational opportunities for all students of the Newton County Schools." The Board members noted they would "miss his commitment and dedication to upholding public education principles and policies, his willingness to listen to concerns of the public, and his unique ability to discern quickly what is in the best interest for public education in Newton County."

Board chair, Mrs. Henderson-Baker, presented the framed proclamation to Mrs. Anita Turner during the funeral service at Springfield Baptist Church in Conyers. In addition, Samantha Fuhrey awarded Mr. Turner posthumously with the Superintendent's Coin of Distinction. Mrs. Fuhrey reserves her Coin of Distinction to people who are "heroes" and those who "dedicate their lives to serving others, go above and beyond, seek nothing in return for their actions and deeds and serve as an example to be emulated."

Mr. Turner was buried with full honors at Lawnwood Memorial Park in Covington, Georgia. He was 69.

NCSS Farns Accreditation

he AdvancED Global Commission approved Newton County School System (NCSS) and each of its schools for accreditation. According to Dr. Shelia Thomas, Chief Strategy and Support Services Officer for NCSS, the district was awarded accreditation by the North Central Association Commission on accreditation and school improvement, the Northwest Accreditation Commission and the Southern Association of Colleges and Schools Commission on Accreditation and School Improvement.

"These three regional agencies provide our institution with a highly regarded accreditation that is recognized throughout the world," said Thomas. "Newton County School System has been granted district accreditation, which extends accreditation to each of the schools in the district."

In March 2019, Newton County School System hosted an AdvanceD External Review visit during which a team of educators from across the state and nation evaluated the school system and a cross section of schools on how the system as a whole adheres to the AdvanceD Accreditation Standards.



"AdvanceD accreditation is a rigorous process that demonstrates to our students, parents and community that we are focused on raising student achievement, providing safe and enriching learning environments, and maintaining efficient and effective operations, staffed by highly qualified educators," said Samantha Fuhrey, Superintendent of Newton County Schools.

To earn AdvanceD School System Accreditation, systems must: meet the AdvanceD Accreditation Standards in the areas of Leadership, Learning and Resource Capacities; implement a continuous process of improvement; and host an External Review team visit once every five years.

The AdvancED Team found Newton County School System met the requirements for accreditation. Newton County School System received an Index of Education Quality (IEQ) score of 321 out of a possible 400, which is a holistic measure of overall performance based on a comprehensive set of standards and review criteria. An IEQ score below 250 indicates that the institution has several areas within the Initiate level and should focus their improvement efforts on those Standards within the Initiate level. An IEQ in the range of 225-300 indicates that the institution has several Standards within the Improve level and is using results to inform continuous improvement and demonstrate sustainability. An IEQ of 275 and above indicates the institution is beginning to reach the Impact level and is engaged in practices that are sustained over time and are becoming ingrained in the culture of the institution.

Newton County school board members broke ground on the site for the new high school to replace the current Eastside High School. The property is located on State Route 142 near the intersection of U.S. Highway 278.

RA-LIN and Associates of Carrollton, Georgia is building the new school, which is scheduled to open August 2022. Upon its completion, the school will accommodate 1,650 students.

Liberty Middle School Student Saves Friend's Life at School

It was just a typical day at Liberty Middle School. Sixth-grader, Christian Swope, was eating his lunch in his class when he sensed a classmate was in danger. He instantly recognized the signs that his friend was choking and couldn't breathe. Christian ran to his aid, performed the Heimlich maneuver, and successfully dislodged the food from his friend's throat before a tragedy could occur. He is only 12 years old.



"My friend was choking and couldn't breathe," said Christian. "My Auntie is a nurse and she taught us how to do CPR and the Heimlich so I wasn't scared because I knew what to do."

After the frightening experience, when they determined his friend would be okay, Christian said his classmates, "called me a lifesaver and they clapped for me."

When asked how he felt Christian said, "I feel good. And I feel proud of myself. When I got home my auntie called me a hero."

When Newton County School System Superintendent Samantha Fuhrey learned of Christian's actions she made it a point to meet him. She paid a surprise visit to Liberty Middle School shortly afterwards to meet Christian and present him with her Superintendent's Coin of Distinction.

"This coin is reserved for the individuals who go above and beyond because it's the right thing to do; they are selfless and demonstrate their commitment to others through their actions and words," Fuhrey explained to Christian as she presented him the coin. "Very few people receive the Superintendent's Coin of Distinction, but you get it because you're a hero. You saved someone's life when you performed the Heimlich maneuver in the classroom and that is most definitely worthy of the Superintendent's Coin of Distinction."
