- As a minimum, each substitute teacher shall hold a high school diploma or its equivalent (GED certificate) and have participated in the initial substitute teacher training provided by Griffin RESA and/or Newton County Board of Education.
- Any Classroom-teacher absence or vacancy that lasts 46 or more consecutive days in a school year shall be filled with a certified in-field teacher, except in situations where longer periods of time are required by state or federal law.
- Substitute teachers who hold only a high school diploma or GED certificate shall not work in any one classroom more than 10 consecutive days.
